Received only one bid which was \$6 million over budget. Four years in the making. Parcel is 4.7 acres. Town of Hardwick will be the owner.

The NVEDD Board often fields request for letters of support for grant opportunities. It is the policy of the Executive Committee that we will draft a letter of compliance relative to our CEDS but not a support letter per se.

Chris Saunders will be leaving Senator Leahy's office after almost 20 years. His replacement will be Jeff Van Oot along with Charles Martin. Will Stevens was representing Senator Sanders office, Will was a former Vermont Representative in Montpelier.

Fauna from Congressman Welch's office touched on funding legislation (Restaurant Relief) to assist restaurants. Monday April 18th is the deadline for the appropriation request. Will shared the Senator's appropriation deadline and Senator Leahy's deadline has passed. Tasha thanked the delegation for their help with the Elmore Store. Paul M. touched on a conversation with Senator Sanders re: the Newport VA clinic.

Do we want to meet in person and visit a potential project? Tasha suggested a Smuggler's Notch visit, to look at an environmental project, or the visit the Rail Trail and lastly possibly a visit to St. Albans City and do a downtown walk. Consensus was to visit St. Albans Downtown.

PARTNER UPDATES: Natalie from ACCD, they have received many NBRC application inquiries. NBRC Letters of interest will need to be submitted by April 22nd. The federal allocation is \$4.5 million.
