## Regional CEDS Updates:

This 2023 Annual Report of the Northern Vermont Economic Development District is the third update on the economic conditions of the district based on implementation of actions recommended in 2021-2025 NVEDD CEDS Plan. The Plan identifies six interconnected goals that promote a thriving, resilient region with a diverse, sustainable economy:

- Goal 1: Building Economic Resilience;
- Goal 2: Cultivating Business Growth;
- Goal 3: Improving and Expanding Infrastructure;
- Goal 4: Developing the Workforce;
- Goal 5: Investing in the Quality of Life in Communities; and,
- Goal 6: Disaster Preparedness and Recovery.

The disaster preparedness and recovery goal creates a foundation of economic resilience in the region and is both an outcome and a strategy that informs the development of five other interdependent goals. Investments made in the development of each of these goals can have a positive impact on each of the other goals. What follows is a snapshot of economic indicators with highlights of investments in some of the goals across the region.

During 2023, outdoor recreation continued to be an important driver of the region's economy, however at times faced setbacks primarily as a result of flooding that impacted a number of communities in our district. Large sections of the Lamoille Valley Rail Trail were wiped out by flood damage just days before the trail's official opening, impacting communities that were counting on this to increase tourism and consumer spending at businesses on and around the trail. These flooding events highlighted the need to prioritize disaster preparedness and recovery in order to create a foundation of economic resilience in the region.

The district continues to face long-term challenges that will have a significant impact on future economic prosperity. Declining birthrates and an aging population have impacts on the current and future workforce, and climate change and the resulting increase in natural disasters like flooding underpin the potential economic setbacks our region may face. Lack of housing is the biggest barrier to attracting workers to the region followed closely by lack of quality, affordable childcare options which continue to be a major issue for current and prospective residents.

Cultivating Business Growth	Fonda Site Rehabilitation	Formerly a paper processing facility in St. Albans, the Fonda site on Lower Newton Street sat vacant for over a decade due to pollution that had permeated into the ground. However in May of 2023, after an extensive \$3,000,000 cleanup effort, the American Rail Dispatching Center became the first new office to open its doors at the site, keeping 61 employees in the region that help coordinate 800 trains daily for 100 railroads across 42 states. The site will soon house 33 senior apartments being built by Cathedral Square, a non-profit based out of South Burlington. This project is slated to begin construction in May 2024.	Ongoing

		The town of North Hero received over \$2.2 million from the Northern Borders Regional Commission, Community Recovery and Revitalization Grant, and Congressionally directed spending to address frequent breakages affecting village businesses. 		The Village of Jeffersonville secured almost a million dollars in funding from the Northern Boarder Regional Commission and Congressionally Directed Funding for critical upgrades to their municipal water system. The village completed construction of the first phase of these improvements in the fall of 2022 and began the engineering of further improvements in 2023.	

		Since 2019, the LCPC has been assisting the Town of Wolcott with coordinating a study of options to address wastewater limitations in the Village Center. In June of 2023, a "Preliminary Engineering Report" identified an option for a shared leach field located at the Wolcott Elementary School. The location is particularly important for Wolcott, given that it is located outside of the floodplain. During the July 2023 flood, many homes in Wolcott experienced damage to their leach fields and sewage backup due to onsite septic systems located in the floodplain. In addition to providing opportunities to revitalize less flood prone areas of the Village, the wastewater project will also reduce this risk during future floods.

Disaster Preparedness and Recovery	LVRT Flood Recovery	In July heavy rain and flooding caused significant damage to the Lamoille Valley Rail Trail, shutting down large sections just days before its official opening. The entire trail was assessed for damage and in August nearly 50 miles of the 93-mile-long trail were able to reopen as a result of extensive collaboration and work from rail trail program staff and maintenance teams. Despite additional flood damage in December, all sections of the trail were able to open for winter use as a result of recovery work throughout the end of the summer and fall. Additional work will be done in 2024 to fully repair segments of the trail in the central part of the state that received the most damage.	Ongoing

# **Challenges and Mitigation:**

Disaster preparedness and recovery continued to be a major priority as summer flooding impacted many communities throughout the NVEDD region in 2023. Flood recovery was a priority in the region for much of the latter half of the year, highlighting the importance of planning for natural disasters and encouraging sustainable development. Lack of housing options and childcare remain as two of the larger concerns for the region as well, as both make it difficult for workers to relocate to the region to fill open jobs and negatively impact economic development. Much has been done to grow the affordable housing stock in the region, however more work is required to meet the demand of Vermonters and potential new workers looking to relocate.

# **Next Steps:**

- Maximize content on NVEDD's <u>website</u> including regular updates to the new <u>Funding</u> Opportunities Search Tool and adding a section highlighting regional success stories.
- Continue to support the region's three Communications Union Districts with the buildout of affordable, reliable high-speed broadband internet service throughout the NVEDD region, specifically currently under-served areas.
- The NVEDD partners will continue to work with State Agency partners to facilitate
  regional rail trail councils and a develop a trail friendly business program for the LVRT,
  modeled on the MVRT Trail Friendly Business Program, to improve quality of life in the
  region and support economic development in our rail trail communities.
- NVDA, in partnership with Do North Coworking, will continue to work with the Center on Rural Innovation (CORI) to develop the Northeast Kingdom's digital economy
- The NVEDD partners will continue to work together to implement the NVEDD Recovery Plan.

#### **Client Success Stories:**

## **Granary Building**

In Jeffersonville, the LCPC assisted the new owner of the Granary building with site planning ideas to enhance this Brownfield property's appearance, its repurposing as a local food businesses hub, and restoring a segment of a former railroad as a bike/ped connection to the adjacent village. A strong vision of the site's reuse and the positive impact this creates in the broader community set a solid foundation for the project's permitting under BRELLA. The granary also received a Downtown Tax Credit to further redevelopment.

#### Perley Block

Franklin County Industrial Development Corporation purchased the historic Perley Block building in June 2022 as part of its new mission to be community focused. After renovating the first floor into office and retail space, the Perley Block is now home to Franklin Northeast Supervisory Union's administrative offices, and two small businesses, B's Flowers and Healthy Nutrition. The second floor houses 8 fully-occupied apartments, which will be renovated as they are vacated. FCIDC is also renovating an attached structure into office space for use by Northwest Counseling and Support Services (NCSS) and has plans to add four additional apartments.

## Caplan's Building

In 2023, Northern Express Care moved into the recently renovated Caplan's Building, doubling their available space and providing a more accessible location compared to their previous home elsewhere in St. Johnsbury. The Caplan's building renovation, made possible by funds received through a Downtown and Village Center Tax Credit and Preservation Trust Grant, created two new commercial units in downtown St. Johnsbury while maintaining and repairing historic aspects of the building such as its façade, vintage signage, and the original hardwood floors. The second unit, currently serving as a box office for Catamount Arts and the Fried Family Gallery will eventually e leased to a new tenant; however Norther Counties Health Care has expressed interest in leasing to another retail tenant to honor the history of the building.

# Alburgh Family Clubhouse

The Alburgh Family Clubhouse, set to open in July of 2024, will provide early care, education, food services, and an afterschool program for 62 local children from birth to fifth grade. The project received a \$500,000 Community Recovery and Revitalization Grant in 2023 that will aid in the construction of this facility and provide care for at-risk children during a time when Vermont families are struggling tremendously to access affordable childcare. The clubhouse will primarily focus on enrolling children in Alburgh, as it is estimated that regulated childcare available in the town meets less than 20% of current demand.

#### Town of Highgate Village Core Project

In 2017, the Town of Highgate purchased a blighted project in the Village Center with the hopes of cleaning it up and redeveloping it with some commercial lots. Work throughout the years has brought about a partnership in 2023 with Cathedral Square for 30 units of much needed housing for ages 55 and up. This achievement, as well as future plans for a new Public Library & Community Center, renovation of the Historic Stinehour Hotel and Stagecoach Inn in our Village Center, and the pursuit of new businesses, has been realized through these major guideposts:

## Forestry Accelerator

Eight startups from Vermont, Maine, Pennsylvania, California, Oregon, and British Columbia completed the rigorous Forestry Accelerator, a program of Northern Vermont University and Do North Coworking, in the Fall of 2023. The four-month program is open to Northern American-based pre-seed and startup companies that are commercializing new and improved products, services, and technology in the forest industry. The program includes an intensive curriculum developed by ecosVC with in-person and virtual workshops, webinars, and 1:1 coaching, as well as connections to industry experts, customers, suppliers, and partners. The Forestry Accelerator supports both the northern forest economy and emerging companies bringing products and services to market in three key areas: 1) products that use chips, dust, resins, and other byproducts and low-grade wood; 2) Technology that improves forest management and operations; and, 3) Products that develop and improve advanced wood heat, fuels, and energy. Applications for the third cohort will be accepted in the Spring 2024.
